- Based in Hampden or Hampshire Counties or a member of the Springfield Regional Chamber.
- At least 3 full years in business.
- Companies may be nominated by bankers, attorneys, financial services, accountants, etc. or self-nominated.
- **The nominating organization is responsible for the completion of this form and for informing company of nomination if not self-nominated.**
